## Lan Oak Park District Committee of the Whole Meeting March 18, 2024

The meeting was called to order at 6:31 p.m. by President Tropp. The following were present: Commissioners Kelly, Shaffer, Aguilar, Tropp. Absent: Lewis. Staff Present: Senior Superintendent of Strategy & Operations Desjardins, Superintendent of Park & Maintenance Havran, Superintendent of Recreation McMahon. Guests: Diane Lund, Doug Cable.

**Superintendent of Parks and Maintenance – Report:** Havran reported on the increased number of fitness memberships, the plan to purchase new cardio equipment, the replacement of the whirlpool filter tank, the painting of the recreation locker rooms, the plan to purchase an outdoor Playskool sign, the plan for upcoming tree assessments, the readying of park shelters for the summer season, vandalism at the new skate park, the new equipment for the dog park, upcoming projects, fitness/aquatic program enrollment, and current fitness membership numbers.

**Superintendent of Recreation – Report:** McMahon reported on current recreation enrollment numbers, preparations for summer day camp, Playskool progress, new recreation programs being offered this summer, the summer special events, and the upcoming easter egg hunt scheduled for March 30. Plans for the Mildred Burt Nature Center and a new sensory room in the Eisenhower Center were reviewed. Recreation supervisor trainings and current programs were discussed.
